DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

IMPORTANT: Carefully read all directions, notes and conditions prior to use. Only use this product as directed on the label. For outdoor use only. Oxidation from sun and elements can cause permanent discoloration on outside surfaces. Test on an inconspicuous area before using. Wear eye protection and rubber gloves during use. Formula may stain clothes and shoes - dress appropriately.

Not for use on deteriorated surfaces (old wood, paint, etc.) unless you intend to refinish surface.

DO NOT allow to dry on glass or other surfaces. Avoid windows. If contact occurs, rinse with water.

Follow pressure washer manufacturer's instructions for application & use of cleaning solutions.

To kill and remove mold and mildew:

1. Spray surrounding plants with water using a garden hose.
2. Add product to pressure washer detergent tank. Ensure tank is clean before filling with product.
3. Wash surface with cleaner using LOW pressure spray nozzle. Coat the area, working from the ground upward.
4. Allow to work for 10 minutes.
5. Rinse surface with water using HIGH pressure nozzle.
6. Spray surrounding plants with water [using a garden hose] after use.
7. Rinse detergent tank with water prior to storage.

STORAGE AND DISPOSAL:

Store with lid closed in areas inaccessible to children, in a cool dry area, away from direct sunlight and heat to avoid deterioration.

Container Handling: NONREFILLABLE CONTAINER. Do not reuse or refill this container. Offer empty container for recycling or discard in trash. Do not reuse this bottle for any other purpose.

Contains no poisonous acids, petroleum distillates or phosphates.
