DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

IMPORTANT: Carefully read all directions, notes and conditions prior to use. Only use this product as directed on the label. For outdoor use only. Oxidation from sun and elements can cause permanent discoloration on outside surfaces. Test on an inconspicuous area before using. Wear eye protection and rubber gloves during use. Formula may stain clothes and shoes – dress appropriately.

Surface Preparation: Use formula at full strength for tough stains or dilute with 3 parts water, one part formula for typical stains and dirt. Apply with a garden sprayer, roller or sponge. Apply full strength with a garden sprayer. Do not use a high power pressure washer to apply.

To kill mold and mildew: 1. Spray surrounding plants with water before and after use. 2. Start from the bottom and work upwards. Wait 10 minutes. 3. Rinse well with water. Heavy stains and textured surfaces may require light scrubbing and a second application.

To clean and remove mold and mildew stains: 1. Spray surrounding plants with water before and after use. 2. Start from bottom and work upwards. 3. Rinse well with water. Heavy stains and textured surfaces may require light scrubbing and a second application.

STORAGE AND DISPOSAL: Store with lid closed in areas inaccessible to children, in a cool dry area, away from direct sunlight and heat to avoid deterioration. **Container Handling:** Nonrefillable container.
